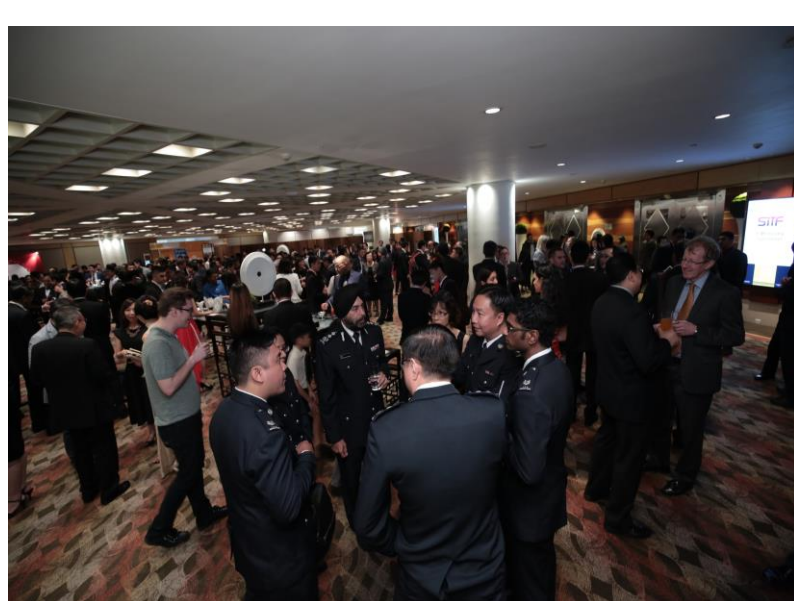
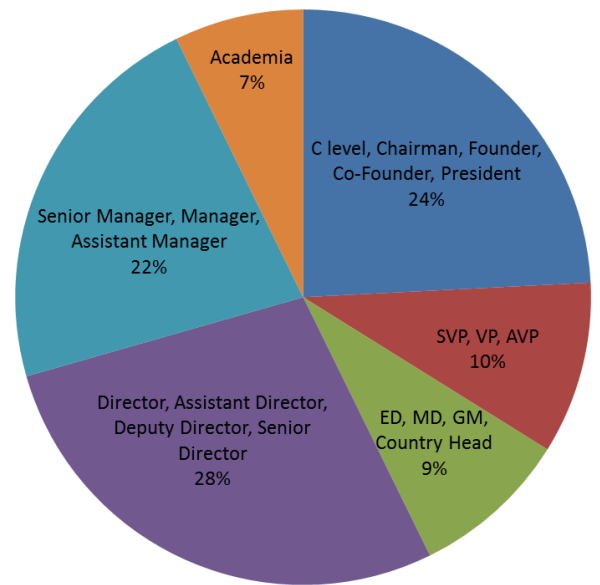

TERMS OF AGREEMENT/CONTRACTUAL RULES

Please read the following agreement and initial on page.

1. INDEMNITY AND LIMITATION OF LIABILITY

Except for negligence or wilful misconduct, neither SiTF, sponsor, any co-sponsor, exhibitor, meeting facility, or other exhibit space provider, nor any of their officers, agents, employees, facilities, other representatives, or assigns shall be liable for, and are hereby released from, any claims for damage, loss harm, or injury to the person, property or business of the parties or any of its visitors, officers, agents, employees, or other representatives, resulting from theft, fire, earthquake, water, unavailability of the exhibition facility or intermediate staging facilities, accident, or any other reason in connection with the event or any planning meeting, demonstrations, or staging.

The Sponsor and SiTF (as the "Indemnifying Parties") shall indemnify, defend, protect and hold the other (the "Indemnified party"), their officers, directors, agents, and employees, harmless from: any and all third-party claims, demands, suits brought or threatened; damages, losses, costs, reasonable attorneys' fees and expenses which result or arise from negligence or willful misconduct in connection with the Indemnifying Party's participation in the Forum, provided that (i) the Indemnified Party gives prompt notice of the claim to the other party; (ii) the Indemnifying Party has sole control over the defense of the claim, including any decision to settle; and (iii) the Indemnified Party provides the other party with all reasonable assistance therein. SiTF shall not be responsible for the security of Sponsor's equipment or its proprietary software or hardware information, and Sponsor shall have full responsibility for any theft or other loss, including any subrogation claims by its insurer. It is the responsibility of the Sponsor to maintain proper insurance coverage for its property and liability.

2. RIGHT TO REFUSE

SiTF reserves the right to review and reject any application for sponsorship without prejudice.

3. CANCELLATION OR TERMINATION OF EVENT

If for any reason beyond its reasonable control, including fire, strike, earthquake, damage, construction or renovation to the Meeting Facility, government regulation, public catastrophe, Act of God, any similar reason, SiTF shall determine that the event or any part may not be held, SiTF may cancel the event or any part. In that event, SiTF and Sponsor shall mutually determine the refund to the Sponsor for its share of the balance of the aggregate fees which remain after deducting all expenses incurred by SiTF.

4. SPONSOR CANCELLATION

There are no refunds for cancellations by exhibitors/sponsors. If an exhibitor/sponsor cancels at any time, for any reason, the exhibitor/sponsor will be responsible for the entire Exhibition/Sponsorship fee. SiTF reserves the right to relocate or reschedule programs. If rescheduled conference does not mesh with the exhibitor's/sponsor's needs or schedule, the exhibitor/sponsor may elect to seek a credit to be used on any SiTF conference, valid for one year from the date of the originally scheduled conference dates.

5. LIABILITY

Under no circumstances will any party to this agreement, any co-sponsor or the Meeting Facility or to their exhibit space provider be liable for lost profits or other incidental or consequential damages for any of their acts or omissions whatsoever, whether or not apprised of the possibility or likelihood of such damages or lost profits. Under no circumstances shall SiTF's or Sponsor's liability exceed the amount actually paid by the Sponsor for the sponsorship opportunity. SiTF makes no representations or warranties, including, but not limited to the number of persons who will attend the event.

6. AGREEMENTS TO TERMS, CONDITIONS AND RULES

Sponsor agrees to observe and abide by the foregoing terms and conditions and by such additional terms, conditions and rules made by SiTF, and made known to the Sponsor, from time to time for the efficient and safe operation of the event. In addition to SiTF's right to cancel sponsorship and withdraw its acceptance of the application, SiTF in its sole judgment, may refuse to consider for participation in future events a Sponsor who violates or fails to abide by all such terms, conditions and rules. This application represents the entire agreement between the Sponsor and SiTF concerning the subject matter of this application. SiTF is not making any warranties or other agreement except as set forth above. Any amendment to this contract must be in writing, signed by SiTF. The headings used in this agreement are for organisation purposes only and are not to be used in the interpretation of the substance of this agreement. The rights of SiTF under this agreement shall not be deemed waived except as specifically stated in writing and signed by an officer of SiTF. If any term of this agreement shall be declared invalid or unenforceable, the remainder of the agreement shall continue in full force and effect.

This agreement shall be binding upon the heirs, successors and assigns of the Sponsor subject to the terms of the agreement regarding assignment.
